

ABSTRACT FROM MINUTES OF THE MEETING OF THE BOARD OF HUDSON RIVER REGULATING DISTRICT HELD AT THE OFFICE OF THE BOARD, 44 HOWARD STREET, ALBANY, N. Y., ON FRIDAY, JANUARY 30TH, 1925 AT 1.30 P. M.

- "WHEREAS, pursuant to Section 450 of the Conservation Law, the Board of Hudson River Regulating District on January 23rd, 1924, made a determination that the Sacandaga Reservoir should be constructed and on the same date approved preliminary plans, specifications, estimates, maps, surveys and statements for such reservoir, and certified the same to the Water Control Commission for its approval as provided by law; and
- "WHEREAS, the said Commission after hearing the Board on March 6, 1924 approved of the said preliminary plans, specifications, estimates, maps, surveys and statements, which were duly filed as provided by said law; and
- "WHEREAS, upon the completion of the filing of said preliminary plans, specifications, estimates, maps, surveys and statements, the Board, pursuant to said law, gave notice of the filing thereof and of a public hearing thereon, and in accordance with said notice, the Board, on April 9th, 1924 gave a hearing on said preliminary plans, specifications, estimates, maps, surveys and statements to persons and public corporations interested therein; and
- "WHEREAS, pursuant to Section 451 of the said Conservation Law, on May 7th, 1924, the Board, after a careful consideration of the evidence and arguments given at the said hearing and of the objections and other exhibits and documents filed with the Board, made a determination that the public welfare requires that the proposed Sacandaga Reservoir should be built and that no modification should be made in the said plans, specifications, estimates, maps, surveys and statements except as modified by the Water Control Commission, and did finally order and direct that the said Sacandaga Reservoir should be built in accordance with the said preliminary plans, specifications, estimates, maps, surveys and statements as approved as modified by the Water Control Commission; and
- "WHEREAS, the said determination and final order were duly filed as provided by law, said filing being completed on May 12th, 1924; and
- "WHEREAS, no proceedings were instituted within thirty days from the date of filing of the same, to review said final order, the Board pursuant to Section 458 of the Conservation Law has prepared an estimate of the total cost of such reservoir, including interest on certificates of indebtedness to the maturity thereof and compensation for real estate and all damages suffered by reason thereof and all expenses necessarily incurred or to be incurred in connection therewith, and has made a complete and verified statement thereof; and
- "WHEREAS, the Board, or a majority of the members thereof, has viewed the premises and public corporations benefited; and
- "WHEREAS, the Board pursuant to said law, has made an apportionment of such cost, less the amount which may be chargeable to the State, among the public corporations and parcels of real estate benefited in proportion to the amount of benefit which will inure to each such public corporation and parcel of real estate by reason of such Sacandaga Reservoir; therefore be it
- "RESOLVED, that the said apportionment of cost of the said Sacandaga Reservoir prefixed hereto be, and hereby is, approved; and be it further
- "RESOLVED, that the said apportionment be, and hereby is certified to the Water Control Commission for its approval."
